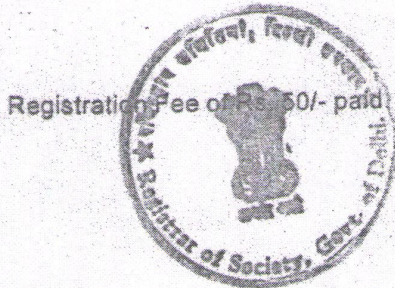

- I. Name : The Name of the Society shall be "ACTION FOR WELFARE AND AWAKENING IN RURAL ENVIRONMENT"
Short Name: "AWARE"
- II. Registered Office : The Registered Office of the Society - Action for Welfare and Awakening in Rural Environment (AWARE) shall be situated in the Union Territory of Delhi, it is present at - H.No:25/4, West Patel Nagar, New Delhi - 110008
- III. Extent : The activities of the Society may extend throughout India

AIMS AND OBJECTS OF THE SOCIETY

IV. AWARE is a Rural Development Organisation. It aims for upliftment of villages. It also aims for Research, Training, Evaluation, Documentation and coordination of Rural Development Programmes.

The Society is a non-political, secular, social service organization based on love, humanity and universal brotherhood. Its activities are for the upliftment of tribals, scheduled castes and other weaker sections of the rural people irrespective of race, community, religion, caste or creed with special emphasis on equality and social justice through social education, motivational training, legal assistance etc. The Society aims towards the self-reliance of the people than charity. It is a non-profit oriented organization leading people towards self-reliance, self-confidence and self-dignity.

The main aims and objects of the Society are:

1. To organise, establish, consolidate, maintain, support, develop, propagate and to encourage development, cultural and uplifting activities with special emphasis on tribal development and rural development programme.
2. To develop areas of mutual co-operation and understanding among different voluntary agencies, development organisations, Institutions, groups and individuals functioning in national and international level and contributing in any manner in the development of rural community.

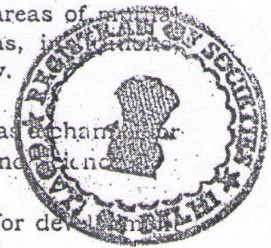
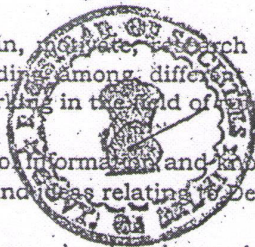

3. To plan, conduct, co-ordinate, assist in all activities related to Research, Investigation, Analysis, Interpretation and Communication of various aspects of National Development.
4. To assist, guide, organise and undertake all activities connected with development.
5. To serve people affected by riots, floods, famines, fires, epidemics, droughts or any other crisis or calamities that effect society from time to time.
6. To assist, organise, plan coordinate and undertake activities that are related to the development and upliftment of downtrodden including those in urban areas such as slums etc.
7. To conduct study groups, lecture series, conferences, seminars, translate, publish, print distribute books, journals, periodicals, literatures etc., for promoting and spreading of knowledge and Indian culture.
8. To develop, cooperate, train, motivate, research and foster areas of cooperation of understanding among different organisations, groups and individuals working in the field of rural technology.
9. To act as a clearing house of information and knowledge and as a channel for interchange of experience and ideas relating to Development and Science.
10. To design suitable programme in planning and utilisation for development organisations.
11. To provide General, Higher, Technical, Medical, Dental, Legal, or any other Professional, Scientific Education to all and shall establish, take over Schools, Colleges, and Institutions of all types and grades. To eradicate illiteracy and to impart higher education, and also to set up training centers and to organize, co-ordinate, conduct training programs for National Development Programs.
12. To act as a coordinating body for providing technical assistance, information, training, advise and other useful services to any development projects.
13. To organise, undertake, coordinate, guide, assist and promote integrated Rural Development programmes.
14. For village upliftment and rural reconstruction promote, organise, take-over or secure and conduct any institutions such as public Health and Hygiene and manage, help, start, establish, conduct, take over any institutions consider necessary to secure the above objectives.

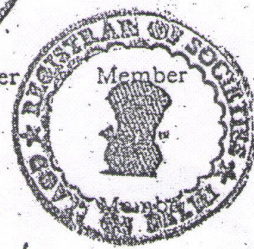

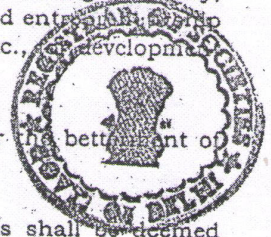
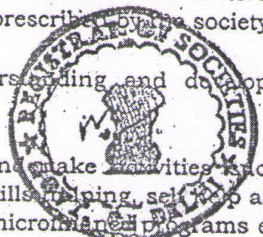

15. To pay or utilise the balances of such interest dividends and other income of the society fund (hereinafter called the net income of the Society) and if the members so desire the corpus of the society or any part of the corpus.
16. To accept donations in cash or kind and to raise funds by advertisements in publications of the society, by arranging cultural shows, by accepting fees, service charges, contributions, subscriptions and other methods.
17. To collaborate with other institutions, associations companies and societies in India or abroad, interested in similar objective.
18. To render assistance to the weaker sections of rural population and other downtrodden people including loans, grants, subsidy etc., in the furtherance of the objectives of the Society and to recover and revolve such loans on such terms and conditions as may be prescribed by the society from time to time.
19. To promote international understanding and developmental cooperation among peoples and nations.
20. To promote, organize, guide, and undertake activities such as legal literacy, health and medical education, skills training, self help and entrepreneurship promotion including thrift, and microfinance programs etc., of development of women for their rightful place in the Society.
21. To organise, assist, conduct and undertake activities for the betterment of labour community in the country.
22. To undertake such other activities from time to time as shall be deemed necessary for the promotion and for the attainment of the aims and objectives of the society - AWARE.
